### FALL 2019 – Important Dates Details

**August 7, 2019 – Dismissal Appeal Deadline** – Last day to appeal a dismissal – due to Admissions and Records by 5pm.

**August 9, 2019** – Regular Registration Ends – Last day to register without a "Student Add Label" from instructor.

**August 12, 2019** – Spring classes begin - full-term (18 week) and 1<sup>st</sup> (9 week).

**August 12 – 30, 2019** – Late Registration for full-term classes. Student must obtain a "Student Add Label" or an emailed Authorization Code for online classes from the instructor. Nine-week classes add and drop dates vary, ask the instructor for specific dates for their class.

**August 23, 2019** – Last day to drop a full-term class and be eligible for a refund. There are no refunds for full-term classes dropped after this date.

**August 30, 2019** – Last day to add a full-term class **in person**. Last day to drop a full-term class **in person** and not receive a "W" on your transcript. **If you are not in good standing or have academic or business office holds you must clear the hold to add your class.**

**September 2, 2019** – Last day to add a full-term class on WebAdvisor with an Authorization Code. Last day to drop a full-term class on WebAdvisor and not receive a "W" on your transcript. **You must be in good standing and have no academic or business office holds in order to add or drop a class on WebAdvisor.**

**August 31 – September 2, 2019** – Labor Day Holiday – the campus is closed.

**September 13, 2019** – Last day to declare Pass/No pass for a full-term class and receive a P or NP on your record in lieu of a letter grade. Short-term class deadline for Pass/No pass is at the 30% mark of the class.

**October 11, 2019** – Last day to drop a full-term class (no drops allowed after this date). You will receive a "W" on your transcript.

**October 14, 2019** – Classes begin for 2<sup>nd</sup> 9-week session.

**November 9 – 11, 2019** – Veterans Day Holiday – the campus is closed.

**November 28 – December 1, 2019** – Thanksgiving Holiday – the campus is closed.

**December 13, 2019** – Last day of the Fall Semester and Last day to apply for Fall Graduation. \*

**December 19, 2019** – Grades expected to be posted to WebAdvisor.

**December 25, 2019** – Campus Closed until January 2<sup>nd</sup>, 2020.

\* (Diplomas and Certificates are mailed out in late March 2020. Invitations to Walk at the Spring 2020 Commencement or Certificate Ceremony are sent to your **student email** in mid-April 2020)
